	Required Qualifications
Membership	To be eligible to apply for core privileges in psychiatry, the initial applicant must meet the following criteria.
Education/Training	Completion of a residency/fellowship approved by Accreditation Council of Graduation Medical Education (ACGME), American Board of Medical Specialties (ABMS), or American Osteopathic Association (AOA) in psychiatry.
Certification	Current certification or active participation in the examination process, with achievement of certification within six years of completion of residency, leading to certification in psychiatry by the American Board of Psychiatry and Neurology or the American Osteopathic Board of Neurology and Psychiatry.
Clinical Experience (Initial)	Applicants for initial appointment must be able to demonstrate the provision of inpatient, outpatient, or consultative services, reflective of the scope of privileges requested, for at least 30

Clinical Experience (Reappointment)

To be eligible to renew core privileges in general psychiatry, the applicant must meet the following maintenance of privilege criteria: Current demonstrated competence and an adequate volume of experience with acceptable results, reflective of the scope of privileges requested, for the past 24 months based on results of ongoing professional practice evaluation and outcomes. Evidence of current ability to perform privileges requested is required of all applicants for renewal of privileges.

			Admit, evaluate, diagnose, treat, and provide consultation to adult patients, presenting with mental, behavioral, addictive or emotional disorders, e.g., psychoses, depression, anxiety disorders, substance abuse disorders, developmental disabilities, and adjustment disorders. Privileges include providing consultation with physicians in other fields regarding mental, behavioral, or emotional disorders; pharmacotherapy; psychotherapy; family therapy; behavior modification; consultation to the courts; and emergency psychiatry, as well as the ordering of diagnostic, laboratory tests, and prescribe medications. Includes the performance of history and physical exams. May provide care to patients in the intensive care setting in conformance with unit policies. Assess, stabilize, and determine disposition of patients with emergent conditions consistent with medical staff policy regarding emergency and consultative call services.

# Child and Adolescent Psychiatry

## Qualifications

## **Education/Training**

To be eligible to apply for privileges in child and adolescent psychiatry, the initial applicant must meet the following criteria: The same as General Psychiatry plus successful completion of an accredited ACGME, ABMS or AOA fellowship in child and adolescent psychiatry or documented experience as evidenced by a letter from department chair or other appropriate designee.

Clinical Experience (Initial) Applicants for initial appointment must be able to demonstrate the provision of inpatient, outpatient or consultative services, reflective of the scope of privileges requested, for at least 15 patients during the past 12 months or demonstrate successful completion of an ACGME, ABMS or AOA accredited residency, clinical fellowship or research in a clinical setting within the past 12 months.

# **Clinical Experience** (Reappointment)

To be eligible to renew core privileges in child and adolescent psychiatry, the applicant must meet the following maintenance of privilege criteria: Current demonstrated competence and an adequate volume of experience with acceptable results, reflective of the scope of privileges requested, for the past 24 months based on results of ongoing professional practice evaluation and outcomes. Evidence of current ability to perform privileges requested is required of all applicants for renewal of privileges.

Includes the performance of history and physical exams. [May provide care to patients in the intensive care setting in conformance with unit policies.] Assess, stabilize and determine disposition of patients with emergent conditions consistent with medical staff policy regarding emergency and consultative call services.

### Qualifications

### **Education/Training**

Completion of a residency/fellowship approved by Accreditation Council of Graduation Medical Education (ACGME), American Board of Medical Specialties (ABMS), or American Osteopathic Association (AOA) in Internal Medicine or General Psychiatry and/or specialized training in Addiction Medicine AND/OR Current certification in Internal Medicine with specialized training in Addiction Medicine or subspecialty certification or active participation in the examination process, with achievement of certification within six years, leading to subspecialty certification in Addiction Psychiatry by the American Board of Psychiatry and Neurology or Certificate of Added Qualifications in Addiction Medicine by the American Osteopathic Board of Neurology and Psychiatry.

Clinical Experience (Initial) Applicants for initial appointment must be able to demonstrate the provision of inpatient, outpatient or consultative services, reflective of the scope of privileges requested, for at least 15 patients during the past 12 months, or demonstrate successful completion of an ACGME, ABMS or AOA accredited residency, clinical fellowship or research in a clinical setting within the past 12 months.

## Clinical Experience (Reappointment)

To be eligible to renew core privileges in addiction medicine, the applicant must meet the following maintenance of privilege criteria: Current demonstrated competence and an adequate volume of experience with acceptable results, reflective of the scope of privileges requested, for the past 24 months based on results of ongoing professional practice evaluation and outcomes. Evidence of current ability to perform privileges requested is required of all applicants for renewal of privileges.
