This document is focused on defining qualifications related to competency to exercise clinical privileges. The applicant must also adhere to any additional organizational, regulatory, or accreditation requirements that the organization is obligated to meet.

Required Qualifications

Required Qualifications		
	Education/Training	Successful completion of an ACGME/AOA/CPME accredited post-graduate training program.
	Certification	The applicant physician must possess current board certification by the specialty board most commonly applicable to his or her specialty, or become board certified as such within six years of completing his or her residency program or receiving medical staff membership or clinical privileges.
	Clinical Experience (Initial)	Applicant must demonstrate that provision of care to at least 12 inpatients or outpatients during the past 12 months.
	Clinical Experience (Reappointment)	Current demonstrated competence and an adequate volume of current experience with acceptable results in the privileges requested for the past 24 months based on results of quality assessment/improvement activities and outcomes.
